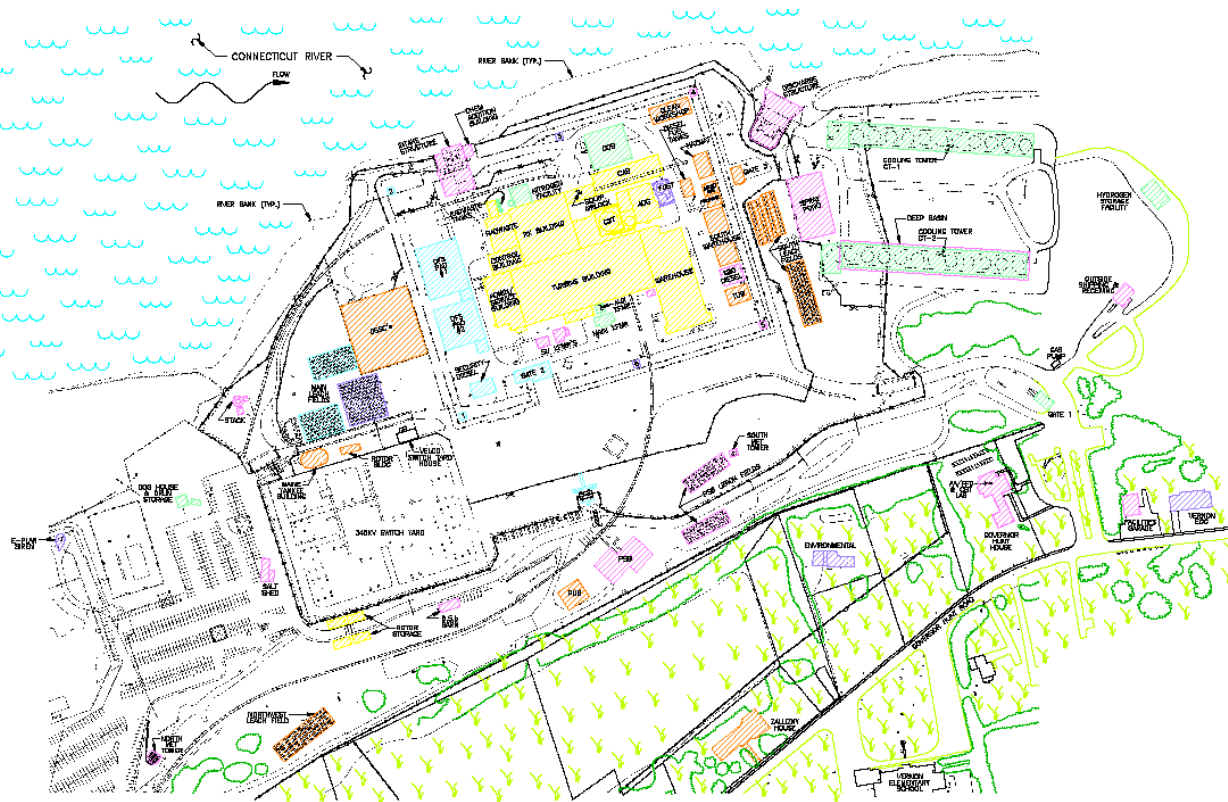

VY Decommissioning Update (Cont'd)

The focus of Entergy Vermont Yankee (VY) and its Employees continues to be our ongoing commitment to Safety.

▶ Vermont State Agency Interactions

- Agency of Natural Resources (ANR) issued a Request for Information (RFI) and Records to VY on March 6th, 2015 as a follow-up to the Site Assessment Study (SAS) and recent work at the site.
- Meeting held between VY and ANR on March 19th, 2015 to discuss the RFI, seek clarification on certain questions and request additional time.
- A response to the RFI will be provided to ANR on Friday, March 27th, 2015.

Site Security

- ▶ There were two (2) recent events of trespassing on the Vermont Yankee property.
- ▶ Trespassing is strictly prohibited and will not be tolerated.
- ▶ VY Security continues to partner with Local Law Enforcement (LLE) as requested to support the site.
- ▶ Additional visual barriers and communications will be employed to reinforce the significance of unauthorized access to the property.
