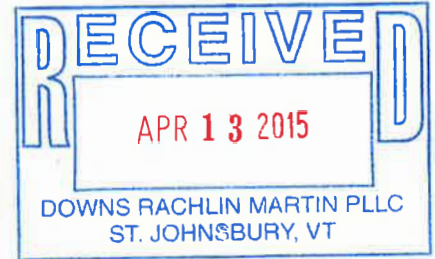


NOTICE OF HEARING
