Dear Chairperson Howe:

As announced in August 2013 and in fall of 2014 Notices of Plant Closure, Vermont Yankee Nuclear Power Station ("Vermont Yankee"), owned by Entergy Nuclear Vermont Yankee, LLC and located at 546 Governor Hunt Road, Vernon, Vermont 05354, is permanently ceasing operations and is being decommissioned. Additionally, the Administrative and Training Building, 185 Old Ferry Road, Brattleboro, VT 05302, is closing. This will result in the permanent elimination of Vermont Yankee and Administrative positions in early 2016. Specifically, 92 employees will experience an employment loss on May 5, 2016. Additionally, 5 employees will experience an employment loss on the following dates:

- June 6, 2016 – 1 Employee
- June 10, 2016 – 2 Employees
- June 30, 2016 – 2 Employees

A list of the affected job classifications and number of affected employees in each is attached.

Some employees are represented by the International Brotherhood of Electrical Workers, Local Union No. 300 ("IBEW"). The IBEW Business Manager is Jeffrey Wimette, and his mailing address is Three Gregory Drive, South Burlington, Vermont 05403. There is a collective bargaining agreement ("CBA") between the Company and the IBEW, and bumping or priority rights based on seniority are discussed in the CBA, including on page 17, as well as in a Memorandum of Agreement between the Company and the Union signed on June 9-10, 2015, including on pages 3-4.
