ENTERGY PETITIONERS' REPLY IN SUPPORT OF THEIR OBJECTION TO THE PUBLIC UTILITY COMMISSION'S PROPOSED RETENTION OF A CONSULTANT

Entergy Nuclear Vermont Investment Company, LLC and Entergy Nuclear Operations, Inc. (together, "Entergy Petitioners") respectfully submit this reply in support of their objection to the Public Utility Commission's ("Commission") proposed retention of a consultant in this Docket.

Subsequent to the Entergy Petitioners' filing of their objection on November 8, 2017, they learned that the Commission had provisionally (*i.e.*, subject to finalization of a contract) selected GDS Associates, and specifically Dr. William Jacobs, as the consultant. The Entergy Petitioners have since been able to review Dr. Jacobs' past work and experience. The Entergy Petitioners are satisfied that Dr. Jacobs does not have a bias that would preclude him from serving as a consultant to the Commission in this Docket. Accordingly, the second portion of the Entergy Petitioners' objection is now moot, and, as far as Entergy Petitioners are concerned, no further process is required before the Commission retains GDS Associates and Dr. Jacobs.

Entergy Petitioners continue to assert the first part of their objection, concerning making public GDS Associates'/Dr. Jacobs' analyses and affording the parties an opportunity to depose
