THIRD JOINT STATUS REPORT

In furtherance of the Commission's Memorandum and Order of April 12, 2018, CLI-18-03, Entergy Nuclear Operations Inc., on behalf of itself, Entergy Nuclear Vermont Yankee, LLC ("ENVY") and NorthStar Nuclear Decommissioning Company, LLC (together, "Applicants"), and on behalf of the State of Vermont and the New England Coalition (together, "Participants"), hereby submits this Third Joint Status Report. The Commission's Memorandum and Order held the Participants' hearing requests in this license transfer proceeding in abeyance based on Participants' anticipated notices of withdrawal pursuant to a Settlement Agreement and pending further notification from the Applicants or Participants.

On December 6, 2018, the Vermont Public Utility Commission ("PUC") issued an Order Approving the Acquisition of Entergy Nuclear Vermont Yankee, Inc. by NorthStar Decommissioning Holdings, LLC and Granting Other Requests Subject to the Memorandum of Understanding. The Order does not alter the terms or conditions of the Settlement Agreement. On December 14, 2014, the New England Coalition withdrew its hearing request.¹ The State of Vermont expects to withdraw its hearing request by December 21, 2018.

The Participants have reviewed this Joint Status Report and authorized Applicants to submit it on their behalf.
